NEW BUSINESS

TEXT AMENDMENT REQUEST: DUNE PROTECTION

Planning Director Hill presented information regarding frontal dunes throughout the Town of North Topsail Beach, and primary dunes located at 40 and 44 Porpoise Place. Division of Coastal Management, Ms. Hill, and the general contractor of the structure at 40 Porpoise Place have been working together since September 2021 addressing dune disturbance, an application for a single-family house, and a swimming pool application. Alderman Swantek requested that the Planning Board review the Town UDO and CAMA Use Plan and consider more restrictive dune protection regulations. There was discussion.

Mrs. Stigall made a motion that we reviewed all pertinent information that the Planning Director provided to us. PROPOSED TEXT AMENDMENT: UDO §4.03.07 FENCES

DISCUSSION

Planning Director Hill reported that she was continuing with code enforcement efforts and issuing Notices of Violation to both the owner, as well as the individual, if not the owner, committing the violation. As the owner is responsible for the compliance, as well as the person conducting the activity. This method has received a lot of attention, but it gives the town the opportunity to do two things: 1) issue citations after the Notice of Violation, collectible through debt set-off; and 2) for a lien to be placed on the property for unpaid fines.
